Project title: Clinical Expansion for Mental Health and Sleep Lab

Project timeline: Q3, 2019

Scope: Project constructs a new 10,000sf building for Out-Patient Mental Health, Mental Health Research, and Sleep Lab. Extension and expansion of utility as required for the new building. No renovation of existing space is included.



Project title: Renovate and Expand Locked Psychiatric Intensive Care Unit for Patient Privacy

Project timeline: Q2, 2019

Scope: This project will renovate the approximately 8,000 sf Psychiatric Intensive Care Unit (PICU) to correct for deficiencies in patient privacy as well as architectural, mechanical, electrical, plumbing, etc. and add approximately 1,500 sf of adjacent new space.

#### Palo Alto OVERVIEW

 The VA Palo Alto Health Care System (VAPAHCS) consists of three major divisional hospital facilities, located in Palo Alto, Menlo Park and Livermore, and a network of seven community based outpatient clinics (CBOCs) and Research and Administrative campuses. VAPAHCS provides primary, secondary, and tertiary care within a large geographical region encompassing a 10 county, 13,500 square mile catchment area. Approximately 272,000 veterans reside within VAPAHCS' primary services area (PSA).

Project title: Construct Gero-Psychiatric Inpatient Rehabilitation Center

Project timeline: August 2019 – October 2020

Scope: Construct a 12,000 GSF Gero-Psychiatric Inpatient Rehabilitation Center at the Menlo Park Division campus. The 12,000 GSF Center will include facilities for physical therapy (PT) rehabilitation, occupational therapy (OT) rehabilitation, and minor procedure and treatment rooms.

#### Palo Alto Current/Future Projects

Project title: Improve Sterile Supply Service and Biomedical Functional Alignment

Project timeline: July 2019 – September 2020

Scope: Renovate 13,000 GSF of deficient Sterile Supply Service and support space in the Building 100 basement area to ensure adequate capacity to perform all sterilization and decontamination functions. In addition, this project will build a 1000 GSF of office space.

- VANCHCS is a 1b complexity health care system which covers over 40,000 square miles and includes a blend of rural, highly rural, and urban areas.
- 12th largest VA health care system in the country
- Two Divisions
  - Sacramento Valley Division is comprised of medical facilities in Sacramento (Medical Center), Chico, Yuba City, Redding, and Yreka
  - The East Bay Division has medical facilities in Fairfield, Vallejo,
     Martinez (Clinic & CLC) and Oakland
- VANCHCS has 191 beds; 10 intensive care, 16 transitional care, 29 medical-surgical, and 16 behavioral health unit beds at the Sacramento VAMC; and 120 Long Term Care beds at Martinez

Scope: This project will construct a new building at the Martinez Campus of approximately 12,000 square feet. This will house our new PRRC for patient services.

Project title: Construct Eye Clinic

Project timeline: Construction Dec. 1, 2020

Scope: This project will construct a new building at the Mather Campus of approximately 12,000 square feet. This will house a new Eye Clinic to support patient care.

Project title: Construct Clinical Building to Replace Modular Building

Project timeline: Construction March 1, 2020

Scope: This project will construct a new building at the Martinez Campus of approximately 12,500 square feet. This will support outpatient clinical services at the site and replace an existing modular building.

Project title: Construct Social Work

Consolidated Clinic Space

Project timeline:

Scope: This project will construct a new building at the Mather Campus of approximately 13,000 square feet. This will support homeless primary care services and consolidate social services at the facility.

Project title: Purchase Land for VAMC Expansion and Parking

Project timeline: Construct March 1, 2020

Scope: This project will provide surface parking on new land recently purchased along with utilities to support the parking areas at the Mather Campus.

Project title: Construct Medical Specialties Building

Project timeline: Construct March 1, 2020

Scope: This project will construct a new building at the Mather Campus of approximately 12,000 square feet. This will support HEMOC services for the facility.



Project title: Construct Primary Care Services

Project timeline: Construct March 1, 2019

Scope: This project will construct a new building at the Mather Campus of approximately 12,000 square feet. This will create a new primary care clinic in the PACT model.

Project title: Specialty Care Clinic Building

Project timeline: Construct May 1, 2019

Scope: This project will replace the exterior façade and apply a new water barrier to the building. Included is a new roof system and cap to ensure a water tight structure.

Project title: Relocate and Expand Dental Services into a Joint Facility

Project timeline: Construct March 1, 2020

Scope: This project will construct a new building on the Travis Air Force Base of approximately 12,000 square feet. This will expand our dental clinic utilization for the area and support the increasing patient load.

Project title: Construct Parking Structure

Project timeline: Construct March 1, 2020

Scope: This project will be a design/build contract to build a multi story parking garage at the Martinez Campus.



Project title: Construct New Dermatology Building

Project timeline: Construct March 1, 2019

Scope: This project will construct a new building at the Mather Campus of approximately 12,000 square feet. This new building will house our new Dermatology clinic for the facility and demolish the existing modular structure.

Project title: Construct and Renovate Space for Chronic Dialysis and Sleep Programs

Project timeline: Construct December 1, 2019

Scope: This project will create 7,000 new square fete to the facility and renovate 4,200 square feet of existing space to increase Hemodialysis services at the Martinez Campus.

Project title: Construct/Renovate Space to Resolve Laboratory Safety

Project timeline: Design: March 1, 2019;

Construct: March 1, 2021.

Scope: This project will renovate the existing laboratory suite at the Mather campus and provide 3,000 square fete of new space to support the lab services.



Project title: Construct Facility for Mental Health and Primary Care Alternative Modalities

Project timeline: Design: March 1, 2019;

Construct: March 1, 2021.

Scope: This project will construct a new building of 21,000 square feet to hour a PRRC and support services at the Mather Campus.
